This order involves a Company Petition filed against Sporta Technologies Private Limited for failing to pay an operational debt of Rs. 7,61,08,246/- since March 2020. Despite objections from the respondent, the tribunal found that the debt existed and admitted the petition. Various orders were issued, including a moratorium on legal actions against the corporate debtor and continuation of essential services.
