#### **SUMMARY OF ORDER**

The National Company Law Tribunal, Mumbai Bench-IV, has admitted an Insolvency & Bankruptcy Code Section 9 petition filed by Nimbus Packaging LLP, claiming Rs. 1.96 crore from Corporate Debtor M/s Supermax Personal Care Private Limited. Despite acknowledging the debt, the Corporate Debtor cites financial difficulties for non-payment. The tribunal validates the debt, Corporate initiates Insolvency Resolution Process (CIRP), imposes a moratorium, appoints an Interim Resolution Professional, and outlines necessary steps for resolution.

#### SUMMARY OF ORDER

The Petition stated that the Corporate Debtor failed to repay a loan. the financial creditor had indeed provided the loan, and the corporate debtor was in default. Consequently, the tribunal admitted the petition, initiating the Corporate Insolvency Resolution Process (CIRP) against the corporate debtor. Mr. Devarajan Raman was appointed as the Interim Resolution Professional, and a moratorium was imposed on certain actions against the corporate debtor's assets.
