Manish Sisodia walks out of Tihar jail after 17 months

CALL FOR FAIRNESS. Long incarceration without trial deprived him of speedy justice: SC

Senior AAP leader Manish Sisodia walked out of Tihar jail after 17 months behind bars on Friday and said he got bail due to the power of the Constitution and democracy and this same power will ensure the release of Delhi Chief Minister Arvind Kejriwal.

Earlier in the day, the Supreme Court gave the former Deputy Chief Minister bail in corruption and money laundering cases linked to the Delhi excise policy "scam" case and said his long incarceration without trial had deprived him of the right to speedy justice.

Kejriwal, who is the national convener of the AAP, is also in Tihar jail in the same case.

SPEEDY TRIAL

Sisodia greeted the party workers and leaders, who showered rose petals on him as he walked out of the jail.

The court granted him bail, noting that he has been in custody for 17 months.

The Supreme Court on Friday sharply rebuked the courts below saying his long incarceration without trial had deprived him of the right to speedy justice.

Observing that "bail is rule and jail is exception", the top court said it is high time trial courts and high courts recognised this principle. "As observed time and

again, prolonged incarceration before being pronounced guilty of an offence should not be permitted to become punishment without trial," a Bench of Justices BR Gavi and KV Viswanathan said, while describing Sisodia as a man with "deep roots in society".

The top court granted him bail in the separate corruption and money laundering cases linked to the alleged Delhi excise policy scam.

Hours later, a Delhi court issued an order for Sisodia's release after accepting the bail bonds and surety bonds submitted by his advocates.

The former Deputy Chief Minister of Delhi was arrested by the Central Bureau of Investigation on February 26, 2023 over purported irregularities in the formulation and implementation of the now-scraped Delhi excise policy 2021-22.

The Enforcement Directorate (ED) arrested him on March 9, 2023.

He resigned from the Delhi Cabinet on February 28 last year.

LEADERS REACTIONS

Soon after the apex court's verdict, senior Aam Aadmi Party (AAP) leader and Delhi Education Minister Atishi said on X "Satyamev Jayate" (truth alone triumphs).

In a post on X in Hindi, AAP MP Raghav Chadha said, "The whole country is happy today as Manish Sisodia, the hero of Delhi education revolution, got bail."

Both Houses adjourned sine die

With completion of listed business for the session, both Houses of Parliament adjourned *sine die*, ahead of the planned end. Lok Sabha Speaker Om Birla said that the lower house had achieved productivity of 136 per cent.

Initially, the session was to end on August 12.

The session saw the Parliament completing the procedure for full Union Budget and introduction of the Waqf Bill which was referred to Joint Parliamentary Committee.

This is also the first time after 10 years any Bill is being sent to JPC. "15 sittings of Lok Sabha were held during the session which lasted for around 115 hours," said Birla.

BILLS INTRODUCED

The general discussion on the Union Budget 2024-25 was a significant focus, engaging 181 members in a debate that spanned 27 hours and 19 minutes.

Throughout the session, the Lower House addressed various matters of public importance, with 400 issues

raised and 86 starred questions answered, he said. 12 Government Bills were introduced and 4 Bills were passed, during the session. Also, 25 Statements were made under Direction 73A and a total number of 30 Statements including two Statements given by the Minister of Parliamentary Affairs in connection with parliamentary business and three suo moto Statements by Ministers were given. As many as 1,345 papers were laid.

The Speaker informed that on July 22, a discussion on India's preparedness for upcoming Olympic Games

was held under Rule 193. Similarly, on 31 July, 2024, a calling attention motion was discussed under Rule 197 regarding loss of lives and property due to landslides and floods in various parts of the country.

With regard to private members' business, 65 private members Bills were introduced during the session.

Private members' resolution moved by Shafi Parambil, MP, regarding appropriate measure to regulate airfare in the country was discussed in the House on 26 July. However, the discussion remained inconclusive.

SC refuses to postpone NEET-PG 2024

The Supreme Court on Friday refused to reschedule the postgraduate National Eligibility-cum-Entrance Test (NEET-PG) 2024 scheduled for August 11. A three-judge Bench headed by Chief Justice of India DY Chandrachud pointed out that two lakh aspirants were expected to appear in the exam.

"More than two lakh students and close to four lakh parents will weep over the weekend if we even touch this matter... Nowadays people just come to post-

pone this exam or the other," Chief Justice Chandrachud remarked.

'CAREERS AT RISK'

Noting that there were only five petitioners in the Supreme Court, the CJ said, "We cannot put the careers of so many candidates at risk just because of these petitioners". Appearing for the petitioners, senior advocate Sanjay Hegde submitted that the controversy over paper leaks and allocation of exam centres in the undergraduate NEET 2024 exam had had an impact on NEET-PG 2024.

"What happened in NEET PG has affected the NEET

PG. Exam centres were cut down from 1,200 to 500," Hegde said. The petitioners had sought postponement of the NEET-PG exam claiming that candidates were allocated cities inconvenient for them to reach.

The CJ, at this point, wondered who was really behind petitions seeking rescheduling of exams. "We don't know who is behind these petitions. We are not talking about your clients... but a larger number of centres always serves the purpose of those who want to cheat the system," the Chief Justice remarked.

Noting that the court was

not in favour of rescheduling the exam, Hegde said the Bench should at least intervene with a direction to the authorities to hold one exam per day.

But the court did not budge. The CJ said, "It is not a perfect world and we are not academic experts. Three of us cannot be expected to sit down and devise a new policy better than the existing one". The NEET-PG exam was initially supposed to be held on June 23. It was postponed by the Union Health Ministry as a "precautionary measure" in the wake of alleged irregularities in certain competitive exams.

JPC on Waqf Bill to give its report in next session

The 31 members of the Joint Parliamentary Committee will submit its report on the Waqf Bill by the next session of Parliament, the government said on Friday. The committee will have 21 members from the Lok Sabha and 10 from the Rajya Sabha.

Minority Affairs Minister Kiren Rijju introduced the Bill in the Lok Sabha on Thursday. Soon after that, it was referred to a JPC. The introduction also saw heated debate, with the government asserting that the proposed

law did not intend to interfere with the functioning of mosques and the Opposition calling it targeting of Muslims and an attack on the Constitution.

On Friday, the Lok Sabha adopted a motion naming its members on the committee. The members include Jagdambika Pal, Nishikant Dubey, Tejasvi Surya, Aparajita Sarangi, Sanjay Jaiswal, Dilip Saikia, Abhikit Gangopadhyay, DK Aruna (all BJP), Gaurav Gogoi, Imran Masood and Mohd Jawed (all Congress), Maulana Mohibullah (SP), Kalyan Banerjee (TMC), A Raja (DMK),

The government is yet to name the chairperson. "The committee will submit its report to the Lok Sabha by the last day of the first week of the next session," the motion approved said.

Smartphone snapshots: A new tool to measure malnutrition in children

The mobile application can accurately determine the child's height and weight by taking photos

A simple smartphone, armed with an intelligent application, is transforming the way we measure children's growth and assess their nutritional health.

This innovative approach, developed by the Raj Reddy Center for Technology and Society (RCTS) at the International Institute of Information Technology (IIIT-Hyderabad), uses computer vision to analyse images captured by a smartphone camera. The app can accurately determine the child's height and weight by taking two photos — one of the child standing against a wall with a height chart and another of the

weighing scale readout.

These measurements are then compared against standard growth charts to identify signs of malnutrition, such as stunting (low height for age) or wasting (low weight for height). The app even sends mobile alerts to parents and local health officials, enabling

timely intervention and care.

The tool has been developed for i-Saksham, an NGO located in Bihar, to support its community engagement programme that trains high school-educated women in leadership and gender issues.

These women, known as

'edu-leaders,' play a crucial role in mobilising out-of-school children and providing social, emotional and life skills training to children in schools and anganwadi.

Arjun Rajasekar, an applied researcher with RCTS, felt that an automated data entry process significantly reduces the subjectivity element, while easing the workload on the workers. It also equips them with an auditing feature, making it much more easier for them. The beauty of this solution lies in its simplicity and accessibility. It eliminates the need for specialised equipment or extensive training, making it ideal for use in resource-limited settings like rural anganwadi centres. Moreover, by automating the

data collection process, it reduces human error and improves the overall quality of data. This smartphone-based solution is not just a technological marvel; it's a potential game changer in the fight against child malnutrition. By providing a quick, accurate and non-invasive method for growth assessment, it empowers healthcare workers to identify at-risk children early and provide them with the necessary support.

The idea is to address the current problems that confront the workers — the challenges in manually measuring growth parameters. This will be accomplished with minimal to no additional hardware requirement other than a smartphone.

Tim Hortons, a Canadian coffee and fast-food chain that debuted with its first store in Delhi two years ago, on Friday said India was one of the fastest growing markets for the brand that has seen a "phenomenal" growth in the country.

"India is one of the fastest growing markets for Tim Hortons internationally. For people like us who entered two years back, there is a huge wide space. Our growth numbers are obviously much higher," Tarun Jain, CEO of Tim Hortons, India, told *businessline* on the launch of the brand's first store in Gujarat on Friday.

Tim Hortons which opened its first store in August 2022, is now

present in 14 cities across India. "We are looking to add 30-40 new stores every year in India. The revenues have been good. Wherever we have gone, people have loved the brand and taken it well. We had huge

queues everywhere where we opened. People were familiar with the brand. They had experienced it when they travelled outside the country — in Canada, Dubai or Singapore. I remember when we opened stores in Bandra and Lokhandwala, we had queues for almost a month. The response has been phenomenal," he added.

When asked if the brand is looking to achieve 120 stores in India by 2026, Jain said, "We are conscious about selecting the right store, so that we get the right revenue, its profitable and its value to the brand. Rather than chasing a number, we are kind of building it up." Jain said cafe business in India was seeing a double-digit growth.

The Tim Hortons store that opened outside the

domestic arrivals at Ahmedabad airport will remain open round the clock. "This is the first store that we are launching with vegetarian Timbits. These are small pieces of desserts which will be 100 per cent egg-less. We have both vegetarian and non-vegetarian food options," Jain added.
